9. Advertisement regarding change of name (other than Marriage/ Divorce case) in two National Newspapers (Urdu/ English) as per specimen (Ad size 5" x 2", along with photograph). Complete Newspaper to be attached (Specimen Attached)

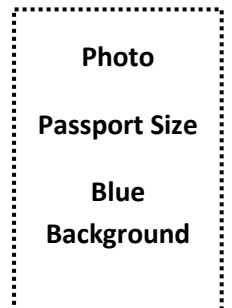
